A. Approval of Minutes – October 2020

B. New Course Requests (School of Liberal Arts & Sciences)

CJUS 3370 (Restorative Justice in America)

Change Effective: Fall 2021 Department: Criminal Justice

Additional information: This course will examine the concept of restorative justice. Specifically, it will examine the stakeholders, outline the basic principles and values, and will introduce some of the restorative justice models used in the United States. Justification: To better prepare our students for success upon graduation in a criminal justice career field, and to be more in line and competitive with regional criminal justice programs including UTA, UTD, Texas A&M Commerce, UT Tyler and Tarleton State University.

CJUS 3380 (Philosophy of Justice)

Change Effective: Fall 2021 Department: Criminal Justice

Additional information: The course will discuss key concepts and claims of the different theories of justice. Students will learn how to critically examine the concrete issues and problems through a justice philosophical framework. Understanding justice form a philosophical framework is critical for students to critically assess fairness in terms of justice and social policy issues. This is core knowledge for any degree justice oriented degree plan.

SOCI 3370 (Frameworks and Analysis)

Change Effective: Fall 2021 Department: Sociology

Additional information: The course provides an introduction to basic social policy, with an overview of the theoretical principles and social context, as well as practical instruments that shape the development of social policy. The Social Policy: Frameworks and Analysis course will service both the Sociology and new Justice and Social Policy programs. This class will serve as an elective in the Sociology program and a required course in the Social Policy program. It will thus benefit both student populations,

contributing to enrollment in two degree programs. No co-requisites and no pre-requisites in order to be flexible for the two degrees. The course cycle is intended to be every other semester as the Social Policy program launches and then offerings will ramp up to once a semester as enrollment increases.

SOCI 3360 (Human Rights and Social Movements)

Change Effective: Fall 2021 Department: Sociology

Additional information: The course provides an introduction to basic human rights philosophy, principles, instruments and institutions, and also an overview of current issues and debates in the field with a particular focus on the impact of social movements on human rights discourse and practice. Human Rights and Social Movements will service both the Sociology and new Justice and Social Policy programs. This class will serve as an elective in the Sociology program and a required course in the Social Policy program. It will thus benefit both student populations, contributing to enrollment in two degree programs. No corequisites and no pre-requisites in order to be flexible for the two degrees. The course cycle is intended to be every other semester as the Social Policy program launches and then offerings will ramp up to once a semester as enrollment increases.

BAJSP - Bachelor of Arts with a major in Justice and Social Policy

Change effective 2021-2022

Department: Criminal Justice and Sociology

This degree is unique as it looks at justice frameworks and human and social justice issues with an emphasis on justice policy. The interdisciplinary degree is in partnership with the department of Sociology.
