### RESEARCH IN PROGRESS

Arxer, S., **Coleman, E.**, LGBTQ Collective Identity Work and Community Healing from Hate-Motivated Violence

The qualitative study focuses on the social psychological processes of collective identity work and the role community-based advocacy/service organizations play in promoting community healing from violence against the lesbian, gay, bisexual, transgender, queer (LGBTQ) community. It considers the ways in which LGBTQ individuals construct and negotiate a collective identity from within community-based organizations as a response to hate-motivated violence. Our research draws on in-depth focus group interviews with two community resource centers in the cities of Orlando and Dallas, which are locations where the deadliest mass shooting in the U.S. history took place, and a string of anti-LGBTQ attacks have occurred. Data analysis will shed light on the personal and social processes of collective identity and how these social psychological dynamics shape larger community connectedness as a response to both direct and indirect hate-motivated violence. Information will also be gained on how community-based organizations promote social and cultural resources that enhance relationships among community partners and community healing from hate-based violence.

This project was a three-year collaboration with the National Policing Institute (NPI), POLIS Research, and the National Institute of Justice (NIJ). This project, funded by an NIJ grant, aimed to develop an automated system for analyzing body-worn camera footage from police officers. Our work culminated not only in the creation of this innovative software but also in a comprehensive NPI/NIJ report disseminating the findings.
