The University of Texas at Arlington (UTA) Research Team is working with participating local jurisdictions, interested parties, and the public to assess fair housing challenges and ultimately provide guidance to program participants in furthering fair housing. The assessment consists of a comprehensive analysis examining not only housing-related challenges but also related to employment, transportation, and accessibility to opportunities.

- The Regional Housing Assessment is a yearlong research project taking place from January 2017 thru January 2018.
 - The scope of the assessment is dual:
 - The analysis is performed for each participating jurisdiction as well as
 - The Dallas Fort Worth Metropolitan area which covers 13 counties.
- The Regional Assessment is led by experienced and outstanding faculty and researchers from diverse disciplines including Urban Planning, Public Policy, Civil Engineering, and Social Work.
 - The research team for this project is comprised of 15 researchers including professors, doctoral students, and masters students.
- Deliverable products include:
 - o The Fair Housing Analysis

- Identify housing and living patterns of integration and segregation, racially and ethnically concentrated areas of poverty, disproportionate housing needs, and disparities in access to opportunity
- Identify contributing factors that cause, perpetuate, or increase fair housing issues
- Public Engagement and Consultation
 - Facilitate public hearings and conduct outreach activities designed to encourage and broaden meaningful public participation
 - Provide continuous information of research related findings
- o Development of Goals and Priorities
 - Prioritization of contributing factors and related fair housing issues
 - Provide guidance in meeting fair housing duties

Fair Park Reinvigoration Plan

The Institute of Urban Studies and researchers engaged with community leaders and Fair Park tenants while exploring national best practices to ensure their commitment to shaping sustainable urban communities.
