UNT-Dallas has nearly 4300 students and is an MSI & HSI institution, with 85% of students coming from communities of color (53% Latinx and 32% African American), a majority of which are low-income, first-generation college students.
- The School of Liberal Arts & Sciences is the largest academic unit with 120 full-time and adjunct faculty, 5 staff and an annual operating budget of \$5.2 million; serving ~1600 students and offering 14 baccalaureate and 2 master's degrees organized into 9 departments.

key values, diversity, innovation, engagement, leadership, community and professional skills
