**PHILLIP C. UMPHRES** is an attorney engaged in private practice as a criminal defense and civil trial attorney in Dallas, Texas. He has served as a military attorney, has been a partner in a nationally known law firm, and was an Assistant United States Attorney for over 16 years prior to returning to private practice in 2008. He has been an Adjunct Professor at UNT Dallas teaching Business Law since 2016.

Mr. Umphres is a native of Amarillo, Texas, a 1977 graduate of the University of Texas at Austin (B.B.A. with highest honors, majoring in Accounting) and a 1980 graduate of Harvard Law School. Following law school Mr. Umphres served for 4 years as a military prosecutor and defense counsel in the U.S. Army Judge Advocate General's Corps. After leaving the Army in 1984 he joined the Dallas offices of the law firm Akin, Gump, Strauss, Hauer and Feld where he was a civil trial and appellate lawyer concentrating in business litigation and appeals. He was a partner at Akin Gump from 1989-1991.

In 1991 **Mr. Umphres** joined the U.S. Attorney's Office in Dallas where he represented the United States in both civil and criminal litigation, spending the majority of his years in the office handling complex white collar and environmental crimes prosecutions. He served at various times as lead Environmental Crimes prosecutor, as coordinator for Criminal Health Care Fraud prosecutions, and as coordinator for criminal investigations involving threats against the President and other federally protected officials. While with the US Attorney's Office he was honored by being selected to be a member of the Department of Justice evaluation team responsible for inspecting and evaluating U.S. Attorney's offices nationwide. He retired from the Department of Justice in 2008.

Since 2008 Mr. Umphres has been a solo practitioner in Dallas, Texas. In 2020 he entered "semi-retirement" and now accepts only a limited number of cases and clients.
