These are predictable challenges that you should plan for by submitting work early and double-checking your submissions.

Assignment Guidelines for Success

When completing any assignment in this course, following a systematic approach will greatly improve your performance. Start by reading all directions thoroughly - this may seem obvious, but many students lose points simply by not following instructions. Make sure you fully understand what the question is asking before you begin writing. Your response should directly address the question and provide complete answers rather than partial thoughts.

Academic writing requires a different approach than casual communication. Write in complete sentences and organized paragraphs, maintaining a professional tone throughout. Avoid slang, emojis, or text-message style abbreviations. Before submitting any work, read through it at least twice to check for clarity and errors. This editing process is crucial for producing college-level work.

Proper citation of sources is non-negotiable in academic work. If you're unsure what plagiarism is or how to cite sources correctly, take the initiative to research these topics using your university's writing center or online resources. Remember that all assignments in this course are individual work unless explicitly stated otherwise - collaboration on individual assignments constitutes academic dishonesty.

Communication and Resources

Email communication in an academic setting follows professional standards. While you may be accustomed to instant responses in other contexts, faculty and staff typically respond to emails within 24-48 hours. When emailing, use clear subject lines and professional language. Before sending a question, check your syllabus first - questions answered in the syllabus will receive a response directing you back to this document.

Your syllabus serves as the primary reference for all course information, including due dates, policies, and assignment details. While Canvas provides reminders, the syllabus remains the authoritative source. Develop the habit of consulting it regularly rather than relying solely on digital notifications.

Fundamental Principles for College Success

Several key principles will guide your success not just in this course, but throughout your college career. First, understand that you will be treated as an adult, which means taking full responsibility for your actions and their consequences. No one will remind you of deadlines or check whether you're keeping up with the material.

Time management becomes your responsibility entirely. For every hour spent in class, expect to spend 2-3 hours studying outside of class. This means a 3-credit course requires 6-9 hours of weekly study time beyond class meetings. Use calendars and planning tools to distribute this workload across the week rather than cramming before deadlines.

Critical thinking forms the foundation of college-level work. This means moving beyond personal opinions to engage with evidence-based knowledge. When presenting arguments, support them with facts from reliable sources. Learn to distinguish between anecdotal evidence and scholarly research. Engage constructively with viewpoints that challenge your own, recognizing that intellectual growth often comes from grappling with new or uncomfortable ideas.

Specific Course Policies

To ensure fairness for all students, this course has several non-negotiable policies. Extra credit opportunities are not offered—your grade relies solely on the work outlined in the syllabus. Requests that give individual students an advantage over others cannot be accommodated. Grade adjustments based on performance in other courses are not possible. When taking quizzes and exams, Respondus LockDown Browser and Respondus Monitoring (webcam monitoring) will be used. Respondus LockDown Browser is not available for Android devices; it is designed for Windows and macOS computers, with a beta version for Chromebooks. The UNT Dallas campus provides students access to computers equipped with the necessary functionality for both Respondus LockDown Browser and Respondus Monitoring, allowing students to take quizzes and exams on campus. If students cannot make suitable arrangements, they can immediately drop the course and choose another one that better fits their situation.

If you anticipate any scheduling conflicts with assignments or exams, <u>notify me at least one week in advance</u>. After-the-fact notifications cannot excuse missed work. The required textbook(s) are essential for success in this course - there is no way to perform well without accessing these materials.

Course Goals/Overview:

The goal of this course is to provide students with an introduction to computer crime through an examination of the crime and those individuals committing it, as well as the specific laws, investigative techniques, and criminological theories applicable to computer crime.

Learning Objectives/Outcomes: At the end of this course, the student will:

- 1. Students will be able to explain current issues, trends, and problems in cybercrime and cyberterrorism.
- 2. Students will be able to differentiate between the concepts of 'cybercrime,' 'cyberterrorism,' and 'information warfare.'
- 3. Students will be able to identify the major social structure theories that apply to cybercrime.
- 4. Students will be able to explain the learning and social control theories that apply to cybercrime.
- 5. Students will be able to explain the evolution of digital crime from rogue individuals to sophisticated criminal organizations engaged in illegal activity.
- 6. Students will be able to provide an overview of the roles of federal law enforcement agencies in addressing cybercrime, as well as interagency partnerships among federal, state, and local levels that involve cybercrime offenses.

◆ If the student <u>DOES NOT</u> meet the minimum word requirement for the student response post as described, the student will <u>automatically receive a O/fail</u> for the assignment, <u>REGARDLESS</u> of how many words the student typed. <u>NO</u> <u>POINTS</u> will be rewarded in consideration of that fact. Follow the instructions.
