Course Evaluation Methods

This course will utilize the following instruments to determine student grades and proficiency of the learning outcomes for the course. All assignments must be submitted and substantially completed in order to successfully complete the course.

Discussion Board Postings: (140 points = 7 discussions x 20 points each)

Each student will be required to post to (7) different discussion board postings during the semester. The discussion board topics will correspond with information from each selected chapter in the textbook. Each student will be required to post an initial discussion and then reply to (2) other student's posts. **Postings will be graded according to the below rubric in each posting.** The discussion board postings will count up to (20) points each (for a total of 0 – 140 total points) toward a student's final grade

Chapter quizzes (140 points = 7 quizzes x 20 points each) – Seven quizzes will be given and they will consist of a combination of standard question formats, such as multiple choice, true false, fill in the blank, free response, etc.

EMS legal consideration project and presentation (100 points)

Students will create an audio and video presentation on the legal and ethical challenges of patients that refuse care and or transportation. This can include video of the student but is not required. A “voice over” presentation of PowerPoint slides is acceptable. Your presentation should be given to an audience of new employees / co-workers. Since this project is open from day 1 of the course, **NO LATE WORK** will be accepted.

Please use a “fictional” EMS organization to avoid specifically identifying any real organization. You have wide latitude in the details, resources, and composition of the fictional organization. However, you should assume the organization is of median size and funding with the expected and reasonable resources that might be common in the industry. Include research-based data with at least five (5) sources. Students will utilize the most current APA edition format guide to provide references.

Reference the grading rubric below. Presentations must be submitted through Canvas as an MP4 file or minus 5 points will be deducted from the final project grade unless otherwise noted by the instructor.

Address the presentation as if presenting new employees / co-workers.

1) Did the presentation address critical aspects and legal considerations of patients who refuse care and or transport?

- 0-25 points

2) Did the presentation discuss the aspects of EMS negligence, how to mitigate EMS negligence, and how it can impact the legal considerations of patients who refuse care and or transport?

- 0-25 points

3) Was the presentation organized, free of grammatical errors, have clear audio/video, stayed on topic, and professionally presented?

- 0-25 points

Note: keep the video presentations under 15 minutes. Minus 5 points from the total project grade will be deducted if the video is over 15 minutes. **Presentations must be uploaded as MP4 files to canvas or it will be minus 5 points from the final project grade.**

4) The presentation discussed actions and or best practices to manage the legal considerations of patients who refuse care and or transport in addition to any protections for EMS employees?

- 0-25 points

Exams (300 points = 3 exams x 100 points each) – Three exams will be given and they will consist of a combination of multiple choice and free response. These will be taken through Canvas. Student will only have one attempt on each exam unless authorized by the instructor. Students will have 60 minutes to complete the exam from the time it is started. Students will not be given another attempt or more time for technology issues. Ensure you are able to complete the exam in one sitting, without interruption, and with adequate technology.

Submitting late or missed course work will be at the discretion of the instructor if not specified in the university excused absence policy.
