Course Overview

This course surveys the social, political, and economic history of the United States from pre-European contact through the Civil War. Themes that may be addressed in this course include American settlement and diversity, American culture, religion, civil and human rights, technological change, economic change, immigration and migration, and creation of the federal government. In addition to a survey textbook, this course will also use primary source readings, maps, art, and some videos to enable students to experience history from the perspectives of its participants.

Learning Objectives/Outcomes: At the end of this course, the student will

1. Demonstrate critical thinking by understanding the key social, political, and economic developments in American History from pre-European contact to 1865.
2. Demonstrate critical thinking and communication skills by writing an analytical essay with a thesis statement drawing on historical evidence from this course.
3. Demonstrate critical thinking, communication skills, and social responsibility by analyzing and discussing written and visual primary sources representing diverse viewpoints.
4. Demonstrate critical thinking and communication skills by defining and explaining the significance of key people, places, and events chosen by the instructor.
5. Demonstrate critical thinking, personal responsibility, and social responsibility by applying these skills in daily life as an active citizen in a democratic society.

General Education Learning Objectives/Outcomes: The UNT Dallas graduate will:

1. Think critically and creatively, learning to apply different systems of analysis.
2. Engage with a variety of others in thoughtful and well-crafted written, oral, and visual communication.
3. Demonstrate social responsibility via intercultural competence, knowledge of civic responsibility, and the ability to engage effectively in regional, national, and global communities.
4. Understand and evaluate personal responsibility by examining ethical issues and considering alternative actions.

Course Evaluation Methods

This course will utilize the following instruments to determine student grades and proficiency of the learning outcomes for the course.

Chapter Quizzes (15 x 15 points each)

Each Chapter Quiz will be taken online through the course website using. Each Chapter Quiz will consist of 15 questions. Chapter Quizzes are open book and untimed, so students will have as much time as they need to answer the questions. More instructions and explanation are available with the quiz on the course website. Chapter Quizzes must be completed by 11:55 PM on the due date specified in the Course Calendar located in the syllabus and online. Chapter Quizzes are not subject to the late policy and will **NOT** be accepted after the deadline.

Response Papers (5 x 25 points each)

Response Papers are short writing assignments based around documents, videos, or other readings that will be assigned by the instructor throughout the semester. Instructions, due dates, and other information for each Response Paper will be discussed in class and posted on the course website. Response Papers must be saved as Microsoft Word Files (.docx) and submitted via the corresponding submit link located on the course website (See Technology Requirements above). Response Papers will be submitted through online plagiarism and AI detection software and may not be accepted if either is found. Instructions, due dates, and other information for each Response Paper will be discussed in class and posted on the course website. See the Late Work Policy below.

Unit Worksheet Quiz (3 x 50 points)

Each Unit Worksheet Quiz is a two-part assignment. For part 1, student will be given a Map Activity Worksheet to take home and complete. For part 2, students will use the completed Map Activity Worksheet to complete a Quiz taken in person during class. More detailed instructions and guidelines, as well as the due date, will be discussed in class and posted on the course website. See the Late Work Policy below.

Extra Credit Paper

Historical Movie Review (25 extra-credit points): The Historical Movie Review consists of selecting a movie from a list provided by the instructor and writing a review following a set of guidelines that will be provided with the movie list.
