Course Goals or Overview:

Phonetics is the study of how the sounds of the world's languages are produced and perceived. Phonology is the study of how these sounds are categorized, contrasted, and organized into larger structures in each language. The aim of this course is to provide the student with the practical skills and the conceptual framework to do further work in phonetics and phonology, especially as this involves the description and scientific explanation of language sound systems. It will give training in the production, perception, physiological and acoustic description, and IPA transcription of the speech sounds used in the English language and associated dialects.

Learning Objectives/Outcomes:

At the end of this course, students will be able to:

- confidently identify and describe the acoustic and articulatory properties of the various sounds of the English language.
- transcribe speech from any English dialect using the International Phonetic Alphabet (IPA).
- identify alterations and patterns between sounds and sound classes in an array of English sociolects.
- produce the sounds found in the International Phonetic Alphabet.
- perform basic acoustic analyses of speech sounds.
- understand and explain basic speech perception phenomena.
- model those patterns and alternations using both rule and constraint based approaches.
- collect and analyze your own data.
