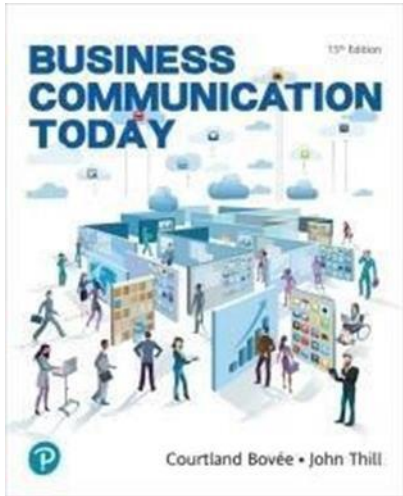

UNTD Attendance and Participation Policy:

Attendance in hybrid courses is measured by the activity of the student within the course. Attendance is considered when students are logged in and actively participating in the learning management system, i.e., participating in synchronous learning opportunities, posting academic assignments, submission of quizzes or exams, participating by posting in discussion boards, and student-initiated email communication with faculty regarding academic course subject matter. Students must establish a record of participation in academically related activities prior to the Census date for the session. Logging into an online course is not sufficient, by itself, to demonstrate attendance by the student. Minimum Attendance Threshold: *At least 80% of class sessions must be attended whether on-line or in person.*

Assignment Policy:

Assignments should be taken as scheduled. No makeup assignments will be allowed except for documented emergencies (See Policy 7.005 Student Attendance at <https://www.untDallas.edu/hr/upol>).

Exam Policy:

Extra Credit:

I do believe in and encourage extra credit work. I believe teaching is a two-way street. Some of the richest course materials available are a result of student feedback. While I am a stickler on grammar and writing skills, I still make my share of mistakes. If you find any mistakes in grammar, punctuation, dates or other correctable course materials that I have written and bring them to my attention, you will receive at least 5 extra credit points. If you contribute to the course with usable, applicable feedback, content or recommendations for content, you will receive no less than 5 extra credit points.

In-Person Course Policies

Electronic Device Policy: This is a communication course that is mostly on-line. Some of the richest content will occur during in-person class discussions. Participation in discussions is paramount. Excessive or disruptive use of any device during an in-person class will be counted as an absence.

Attendance: Since we meet only monthly and you have the dates ahead of time, you are expected to be at every class for the duration of the class (10:00 AM-12:50 PM). They will not be recorded. We will take a break of at least 15 minutes at 11:00 AM and 30 minutes at noon. I will be commuting to Dallas from OKC for our in-person courses. While I do not expect any difficulties, please check the course announcements in the morning before you come to class in case of unforeseen circumstances.

Late Arrival: If you are late for an in-person class, enter quietly and take a seat as far to the back of the class as possible. If there are no seats, please stand. Find the sign in sheet or your tent name card and sign in. Once there is a natural break in the course, you will be asked to move to the front of the classroom for the remainder of the course period.

Guest Speaker(s): Having a guest speaker who is an expert in the field of study in the topic for the week is a *huge* privilege. They are taking time away from their own career in hopes of bettering yours. Please afford them even more respect than you would me as an instructor.

Online Attendance and Participation:

Classroom Disruption:

Students are expected to always engage with the instructor and other students in this class in a respectful and civil manner to promote a classroom environment that is conducive to teaching and learning. Students who engage in disruptive behavior will be directed to leave the classroom. A student who is directed to leave class due to disruptive behavior is not permitted to return to class until the student meets with a representative from the Dean of Students Office. It is the student's responsibility to meet with the Dean of Students before class meets again and to provide the instructor confirmation of the meeting. A student who is directed to leave class will be assigned an unexcused absence for that class period and any other classes the student misses as a result of not meeting with the Dean of Students. material. In addition, the student will be assigned a failing grade for assignments, quizzes or examinations missed and will not be allowed to make up the work.
